Rationale & Key Rating Drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 25, 2024, placed the rating(s) of Sangotra Fashions Private Limited (SFPL) under the 'issuer non-cooperating' category as SFPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SFPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 11, 2025, August 21, 2025, August 31, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of SFPL have been revised on account of non-availability of requisite information.

Sangotra Fashions Private Limited (SFPL) was incorporated in the year 2010 as a private limited company by. SFPL is engaged in manufacturing and exporting of readymade garments for men, women and children's wear like capris, full pants, skirts, tops, shirts, trousers etc. Further SFPL manufacturing unit is located at Bhandup, Mumbai.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of SFPL into Issuer Not Cooperating category vide press release dated May 27, 2025 on account of its inability to carry out a review in the absence of requisite information.
