Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated August 27, 2024, placed the rating(s) of Sriya Farm (SF) under the 'issuer non-cooperating' category as SF had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SF continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 13, 2025, July 23, 2025, August 02, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the firm

Bangalore based M/s Sriya Farm (SF), established in 2003 as a Proprietorship Firm by Dr. M.L. Suresh Babu, and is engaged in poultry integration business, where a contract is given to the framers for production of broiler chicken. SF produces small chicks and keeps them in their hatchery for 21 days after which it is sent to the farmers for further hatching process in their respective local areas. The firm has a capacity of 200 lakhs per annum hatchery eggs production of their own and 130 lakhs broiler birds per annum under contract with local farmers. The firm purchases poultry feeds from its associate concern Sriya Farm and Feed Private Limited which manufacture poultry feed and sole supplier for SF. The firm sells broiler chicken majorly in Karnataka and Andhra Pradesh

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of SF into Issuer Not Cooperating category vide press release dated June 26, 2025 on account of its inability to carry out a review in the absence of requisite information.

Acuite has continued the rating assigned to the bank facilities of SF into Issuer Not Cooperating category vide press release dated June 23, 2025 on account of its inability to carry out a review in the absence of requisite information
