Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 23, 2024, placed the rating(s) of Sree Ganesh Constructions (SGC) under the 'issuer non-cooperating' category as SGC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SGC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 09, 2025, August 19, 2025, August 29, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Established in 2007, as a partnership firm, Sree Ganesh constructions (SGC) is a civil contractor registered with Andhra Pradesh State Public Works Department and is engaged in the construction of bridges, flyovers, railway over bridge, irrigation work etc. The entity has its registered office in Hyderabad, Andhra Pradesh. SGC is managed by Mr. A Uppender Reddy (50% shares), Ms. A Prasanna Latha(25%), Mr. A Hanumantha Reddy (15%) and Mr.J Sandeep Reddy (10%).The entity since inception has been engaged primarily in building of road over bridges (ROB), canal projects, railway projects.
