Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 26, 2024, placed the rating(s) of Sunglow Suitings Private Limited (SSPL) under the 'issuer non-cooperating' category as SSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 12, 2025, August 22, 2025, September 01, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of SSPL have been revised on account of non-availability of requisite information.

Bhilwara (Rajasthan) based Sunglow Suitings Private Limited (SSPL) is promoted by Mr. Mahesh Kumar Hurkat and Mr Meghraj Baheti in 2005. SSPL is mainly engaged in the manufacturing of synthetic fabric and synthetic yarn for own sales as well as on job work. The manufacturing facility of SSPL is situated at Bhilwara.

Status of non-cooperation with previous CRA: ICRA has continued the rating assigned to the bank facilities of SSPL into Issuer Not Cooperating category vide press release dated February 19, 2025 on account of its inability to carry out a review in the absence of requisite information.
