Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 11, 2024, placed the rating(s) of Vimal Platinum Private Limited (VPPL) under the 'issuer non-cooperating' category as VPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. VPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 27, 2025, September 06, 2025, September 16, 2025 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of VPPL have been revised on account of non-availability of requisite information.

About the company

VPPL was incorporated in March 09, 2007 by Mr. Prakash Laddha, Mr. Rakesh Laddha and Mr. Naveen Chordia. VPPL is engaged in the business of manufacturing of synthetics grey fabrics (includes artificial or synthetic filament and non – filament fibers). The company also manufactures grey fabric on job work basis. Further, the company sells grey and finished fabric in the market where it gets finished work done on grey fabrics from other processor on job work fabrics. The plant of the company is located at Bhilwara.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of VPPL into Issuer Not Cooperating category vide press release dated January 03, 2025 on account of its inability to carry out a review in the absence of requisite information.

Acuite has continued the rating assigned to the bank facilities of VPPL into Issuer Not Cooperating category vide press release dated April 25, 2025 on account of its inability to carry out a review in the absence of requisite information.
