Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated October 08, 2024, placed the rating(s) of Vinayak International Housewares Private Limited (VIHPL) under the 'issuer non-cooperating' category as VIHPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. VIHPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 24, 2025, September 03, 2025 and September 13, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.
