Rationale & Key Rating Drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 01, 2024, placed the rating(s) of Paramount Pharma (PP) under the 'issuer non-cooperating' category as PP had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. PP continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 17, 2025, August 27, 2025, September 06, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Paramount Pharma (PTP), based in Jammu & Kashmir was established in May 2006 as a partnership firm. The firm is currently being managed by Mr. S.S. Nandwana, Mr. Pankaj Nandwana and Mr. Rajat Nandwana. PTP is engaged in manufacturing of pharmaceutical formulations in the form of powder namely paracetamol, diclofenac sodium and vitamin C at its manufacturing facility located in Jammu & Kashmir.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of PTP into Issuer Not Cooperating category vide press release dated September 11, 2024 on account of its inability to carry out a review in the absence of requisite information.
