Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 26, 2024, placed the rating(s) of Radiant Rocks Private Limited (RRPL) under the 'issuer non-cooperating' category as RRPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RRPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 12, 2025, August 22, 2025, September 01, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Udaipur (Rajasthan) based Radiant Rocks Private Limited (erstwhile Jaibalajee Marmograins Private Limited) was incorporated in September, 2017 by Mr. Sudhir Sharan and Mr. Hardev Sahu. JMPL was incorporated with an aim to set up a processing unit for processing of marbles and granites blocks.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of RRPL into Issuer Not Cooperating category vide press release dated November 07, 2024 on account of its inability to carry out a review in the absence of requisite information.
