Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 28, 2024, placed the rating(s) of Ridhi Sidhi Electrical Engg. and Const. Company (RSECC) under the 'issuer non-cooperating' category as RSECC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RSECC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 13, 2025, September 23, 2025 and October 03, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.
