### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 16, 2024, placed the rating(s) of Anna Bhau Ajara Taluka Shetkari Sahkari Soot Girani Limited (ABATSSSGL) under the 'issuer non-cooperating' category as ABATSSSGL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ABATSSSGL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 01, 2025, September 11, 2025, September 21, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.
