### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 16, 2024, placed the rating(s) of Varalakshmi Starch Industries Private Limited (VSIPL) under the 'issuer non-cooperating' category as VSIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. VSIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 01, 2025, September 11, 2025, September 21, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of VSIPL have been revised on account of non-availability of requisite information.

### About the Company

Varalakshmi Starch Industries Private Limited (VSIPL), formerly known as Varalakshmi Starch Industries Limited was incorporated on May 16, 1995 as a public limited company and later converted into private limited company. VSIPL is engaged in manufacturing of tapioca starch, tapioca sago and maize starch with an installed capacity of 250 tonnes of maize starch, 150 tonnes of tapioca starch, 150 tonnes of modified starch and 60 tonnes of tapioca sago per day.

**Status of non-cooperation with previous CRA:** ICRA has continued the ratings assigned to the bank facilities of VSIPL to the 'issuer not-cooperating' category vide press release dated September 24, 2025 on account its inability to carryout review in the absence of requisite information from the company.

CRISIL has continued the ratings assigned to the bank facilities of VSIPL to the 'issuer not-cooperating' category vide press release dated September 18, 2025 on account its inability to carryout review in the absence of requisite information from the company.
