Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 25, 2024, placed the rating(s) of Veera Associates (VA) under the 'issuer non-cooperating' category as VA had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. VA continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 10, 2025, September 20, 2025, September 30, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the Firm

Veera Associates (VA) was initially started as a proprietary concern in 2005 with the name of Sarika Cotton Traders and later on the constitution was changed to partnership firm and subsequently the firm was renamed to current nomenclature. The firm is being promoted by Mr. Kuppam Venkata Prasad who has more than 25 years of experience in textile industry. The firm is engaged in manufacturing and trading of polyester viscose yarn and cotton yarn. The manufacturing facility is located at Adapazari, Guntur District, and Andhra Pradesh with a total installed capacity of 1630 MTPA with total spindles of 8160.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of VA to the 'issuer not-cooperating' category vide press release dated November 25, 2024 on account of its inability to carryout review in the absence of requisite information from the firm.
