### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated November 07, 2024, placed the rating(s) of Sankheswaraa Gold Exports Private Limited (SGEPL) under the 'issuer non-cooperating' category as SGEPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SGEPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 23, 2025, October 03, 2025, October 13, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

SGEPL commenced its operations from May 19, 2016 by setting up a plant & machinery for manufacturing of gold chains and bracelets with high quality art and finishing.
