Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 23, 2024, placed the rating(s) of Jai Venkay Poultry Farms (JVPF) under the 'issuer non-cooperating' category as JVPF had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JVPF continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 08, 2025, September 18, 2025, September 28, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Andhra based, Jay Venkay Poultry Farms (JVPF) was established in the year 2008 and promoted by Mr. K Venkata Rao and family members. The firm is engaged in farming of egg laying poultry birds(chickens) and trading of eggs and live birds. The firm sells its products like eggs and live birds in Andhra Pradesh to retailers through own sales personnel. The firm buys chicks (small chickens) from Srinivasa hatcheries private limited, Vijayawada. The firm purchases raw materials like rice bokkens, sun flower cake from local farmers, and soya from Harikrishna & Co, Suvarnalakshmi trading company.
