Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 22, 2024, placed the rating(s) of Shree Narayan Swamy Enterprises (SNSE) under the 'issuer non-cooperating' category as SNSE had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SNSE continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 07, 2025, September 17, 2025 and September 27, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.
