### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 25, 2024, placed the rating(s) of The Phaltan Education Society (PES) under the 'issuer non-cooperating' category as PES had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PES continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 10, 2025, September 20, 2025, September 30, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The Phaltan Education Society (PES) was established in 1951 by Late Shrimant Maloji Raje in Phaltan, District Satara, Maharashtra. PES subsequently took over the management of Mudhoji High School (established in 1893) and extended its reach in the education sector. Currently, PES administers 35 different institutions which include primary schools, high schools, junior colleges, agricultural schools, an agricultural college, a horticulture college, English medium school, senior colleges, IT center, minimum skills vocational centers and an engineering college.
