Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 25, 2024, placed the rating(s) of SPS Educational Trust (SET) under the 'issuer non-cooperating' category as SET had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SET continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 10, 2025, September 20, 2025, September 30, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the trust

Palwal-based (Haryana), SPS Educational Trust (SET) was established in the year 2010 by Mr Sureshchandra Bharadwaj, Mrs. Sunita Bhardwaj, Mr Shyam Sunder, Mr Brijesh Kumar and Mr Ram Kumar Gupta with the object of setting up educational institutions. SPS is running a school in the name of SET International at Palwal (Haryana) since, August, 2011. The school is affiliated to the Central Board of Secondary Education (CBSE) and offers education from Kindergarten to class XII. The school is spread across the area of 5.25 acres and it has all the state-of-the-art facilities like computer labs, library, smart classes, various sports facilities and swimming pool etc.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of SET into Issuer Not Cooperating category vide press release dated October 29, 2025 on account of its inability to carry out a review in the absence of requisite information.
