Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 27, 2024, placed the rating(s) of S. R. S. Sponge Private Limited (SRSSPL) under the 'issuer non-cooperating' category as SRSSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SRSSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 13, 2025, August 23, 2025, September 02, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

However, after incorporation, the company remain dormant and started commercial operation from April 2012. The company installed a sponge iron manufacturing unit at Dantiya in Purulia with an installed capacity of 21,000 MTPA.
