### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 15, 2024, placed the rating(s) of Amar Enterprises (AE) under the 'issuer non-cooperating' category as AE had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AE continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 31, 2025, September 10, 2025, September 20, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

### About the firm

Jodhpur (Rajasthan) based Amar Enterprises (AE) was formed in 1984 as a proprietorship concern by Mr. Mana Ram Bishnoi. AE is mainly engaged in the business of road construction and repair of roads for government departments. AE is registered 'AA' class (highest in the scale of AA to E) approved contractor with Public Works Department (PWD), Rajasthan. The firm takes tenders from government department as well as work on sub-contract basis from private players. Further, the firm also gives work on sub-contract basis to private players.

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of AE into Issuer Not Cooperating category vide press release dated May 22, 2025 on account of its inability to carry out a review in the absence of requisite information.

Brickwork has continued the rating assigned to the bank facilities of AE into Issuer Not Cooperating category vide press release dated July 22, 2025 on account of its inability to carry out a review in the absence of requisite information.
