Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 23, 2024, placed the rating(s) of Sree Jeyasakthi Saw Mill (SJSM) under the 'issuer non-cooperating' category as SJSM had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SJSM continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 08, 2025, September 18, 2025, September 28, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the Firm

Sree Jeyasakthi Saw Mill (SJSM) was established in 2002 as a partnership firm by Mr. P Sanjeev kumar (Managing Partner) and S. Meena (Partner). The firm is engaged in trading (wholesale and retail) of wood and teak products from past 30 years. The firm imports majority of the timber wood from the suppliers located in the international markets like Burma, South Africa, Australia, and Malaysia. The firm sells the products to customers located in Kerala, Tamil Nadu, and Pondicherry and Telangana.

Status of non-cooperation with previous CRA: Acuite has continued the rating assigned to the bank facilities of SJSM into Issuer Not Cooperating category vide press release dated December 28, 2024 on account of its inability to carry out a review in the absence of the requisite information from the firm.
