### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 11, 2024, placed the rating(s) of Addya Sakti Cold Storage Private Limited (ASCSP) under the 'issuer non-cooperating' category as ASCSP had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ASCSP continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 27, 2025, September 06, 2025, September 16, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

### About the company

Incorporated in March 1979, Addya Sakti Cold Storage Private Limited (ASCSP) was initially promoted by the Manna family of West Bengal. However, since January 2017, the entire management of the company has been changed and it is currently managed by the Saha family of West Bengal. Since its inception, the company has been engaged in providing cold storage services to potato-growing farmers and traders on a rental basis with a storage capacity of 16500 metric tons (MT). The coldstorage unit is located at Hooghly, West Bengal. Besides providing cold storage facility the unit also works as a mediator between the farmers and marketers of potato to facilitate sale of potatoes stored and it also provides interest bearing advances to farmers for farming of potatoes.
