Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated November 08, 2024, placed the rating(s) of J P Foods Oil Company (JPFOC) under the 'issuer non-cooperating' category as JPFOC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JPFOC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 24, 2025, October 04, 2025 and October 14, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.
