### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) Ltd. had, vide its press release dated October 29, 2024, placed the rating(s) of Shankheshwar Enterprises (SE) under the 'issuer non-cooperating' category as SE had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SE continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 14, 2025, September 24, 2025 and October 04, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Shankheshwar Enterprises (SE), based in Ludhiana, Punjab was established in 2000 as a partnership firm with Mr. Sudhir Jain, Mr. Harish Jain and Mr. Dhimant Jain as partners. The firm is engaged in manufacturing of knitted cloth and fabrication i.e. embroidery, printing etc. as its facility located in Ludhiana, Punjab.
