### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 21, 2024, placed the rating(s) of ABF Rural Godown (ARG) under the 'issuer non-cooperating' category as ARG had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ARG continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 06, 2025, September 16, 2025, September 26, 2025 among others.
