### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 25, 2024, placed the rating(s) of Digiflic Controls India Private Limited (DCIPL) under the 'issuer non-cooperating' category as DCIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. DCIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 10, 2025, September 20, 2025, September 30, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The company is engaged in designing, manufacturing and commissioning of solar based products like Solar home lighting system, Solar street lighting system, Solar garden lighting system, Solar power Plant, Building integrated photo voltaic, Solar water heating system, Nano water purifier and RO water purifier.
