### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 11, 2024, placed the rating(s) of Dhariwal Steel Private Limited (DSPL) under the 'issuer non-cooperating' category as DSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. DSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 27, 2025, September 06, 2025, September 16, 2025 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Kolkata based Dhariwal Steel Private Limited (DSPL) was incorporated in 1982 and started its commercial operation in 1983. The company is engaged in manufacturing and supplying of prefabricated buildings, foot bridges, shelters, sleeping bunkers, heavy steel structures, steel bridges, transmission line towers Hamilton poles etc. to the government as well as private entities. The manufacturing facility of the company is located at Howrah, West Bengal with an installed capacity of 10,000 metric tons per annum and it has an ISO certification.
