### Rationale & Key Rating Drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 11, 2024, placed the rating(s) of Bakshi Security And Personnel Services Private Limited (BSPSPL) under the 'issuer non-cooperating' category as BSPSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BSPSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 27, 2025, September 06, 2025, September 16, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

(Retd) Omprakash Bakshi and later converted into a private limited company in April 1995, Bakshi Security & Personnel Services Private Limited (BSPSPL) is an ISO 9001:2015 and UKAS-certified company engaged into manpower supply services viz. security services, conservancy services, facility management services (FMS) and housekeeping services to various factories, banks, corporates, IT industries, offices, cargo complexes, defence, cantonment boards, educational institutions, hotels, shopping complexes, departmental stores, etc. across various states in India.

**Status of non-cooperation with previous CRA:** CRISIL continues to categorize rating assigned to the bank facilities of BSPSPL under non-cooperation category vide PR dated July 17, 2025 on account of its inability to carry out a rating surveillance in the absence of the requisite information from the company.
