Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 25, 2024, placed the rating(s) of Alfa Transformers Limited (ATL) under the 'issuer non-cooperating' category as ATL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ATL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 11, 2025, August 21, 2025, August 31, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of ATL have been revised on account of non-availability of requisite information. The revision further considers decline in TOI and reported net losses which has led to a deterioration in debt coverage parameters during H1FY26.

Since its inception, the company manufactures small distribution transformers and offers related technical assistance and services, including repair work. The company executes EPC orders (for electrical installations) on behalf of various public sector entities like Odisha Power Transportation Company Limited (OPTCL) and Paschim Gujrat Vij Company Limited (PGVCL) and Gupta Power Infrastructure Limited (GPIL). The company has two manufacturing units located at Bhubaneswar and Vadodara.
