Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 23, 2024, placed the rating(s) of Sree Sannidhi Foods Private Limited (SSFPL) under the 'issuer non-cooperating' category as SSFPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SSFPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 08, 2025, September 18, 2025, September 28, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the Company

Andhra Pradesh based (Chittoor) Sree Sannidhi Foods Private Limited (SSFPL) was incorporated in 2010. During January 2014, the company was taken over by the current management comprising Mr. Shivam Goyal and Ms. Shavya Goyal. The company is engaged in manufacturing of fruit pulp, tomato paste and trading of fruits; it commenced full-fledged commercial operations from June 2014. SSFPL has total installed capacity of 16,800 tonnes per annum at its manufacturing unit located at Chittoor, Andhra Pradesh.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of SSFPL to the 'issuer not-cooperating' category vide press release dated March 21, 2025 on account its inability to carryout review in the absence of requisite information from the company.
