Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 28, 2024, placed the rating(s) of Rodas Impex Private Limited (RIPL) under the 'issuer non-cooperating' category as RIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 13, 2025, September 23, 2025, October 03, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Bhilwara based (Rajasthan) Rodas Impex Private Limited (RIPL) was incorporated in August, 2001 as a private limited company by Mr. Jugal Kishore Chamodi and Mr. Vinod Chamodi along with family members. RIPL is engaged in the business of manufacturing of grey fabrics as well as trading of grey and finished fabrics.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of RIPL into Issuer Not Cooperating category vide press release dated April 01, 2025 on account of its inability to carry out a review in the absence of requisite information.
