Rationale & Key Rating Drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 17, 2024, placed the rating(s) of S.S.S. Rice Mill Private Limited (SRMPL) under the 'issuer non-cooperating' category as SRMPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SRMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 02, 2025, September 12, 2025, September 22, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the company

Incorporated in May 2007, S.S.S. Rice Mill Private Limited (SRMPL) is engaged in rice milling. The Plant is located at Raidighi, West Bengal with an installed capacity of 75000 MTPA. The company is promoted by Mr. Nimai Chand Pukait and Mrs. Arati Purkait. The company procures paddy from local farmers at Raidighi and after processing, the final produce is sold to the dealers and wholesalers in West Bengal. The company is also involved in job work for Government departments namely WBECSC Limited, BENFED, and Food and Supply Department of West Bengal. Further, the company has not availed any moratorium from its lender.

Status of non-cooperation with previous CRA: ICRA has continued the rating assigned to the bank facilities of SRMPL into ISSUER NOT COOPERATING category vide press release dated November 29, 2024 on account of its inability to carry out a review in the absence of requisite information from the company.
