### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated November 12, 2024, placed the rating(s) of A. K. Builders (AKB) under the 'issuer non-cooperating' category as AKB had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AKB continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 28, 2025, October 08, 2025 and October 18, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.
