### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 21, 2024, placed the rating(s) of Bharat Urban Infra Developers Private Limited (BUIDPL) under the 'issuer non-cooperating' category as BUIDPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BUIDPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 06, 2025, September 16, 2025, September 26, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

### About the company

BUIDPL is a Solapur (Maharashtra) based company promoted by Mr. Nandkishor Shah and was established in August 2015. The company has taken over operations of Bharat Constructions (proprietorship firm) in the year 2015. The company undertakes Engineering Procurement Construction (EPC) contracts in the state of Maharashtra. The scope of work involves construction of roads, canals and dams etc.

**Status of non-cooperation with previous CRA:** Brickwork has continued the rating assigned to the bank facilities of BUIDPL under Issuer Not Cooperating category vide press release dated May 23, 2025 on account of its inability to carry out a review in the absence of the requisite information from the company.
