Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 14, 2024, placed the rating(s) of Shivalik Vyapaar Private Limited (SVPL) under the 'issuer non-cooperating' category as SVPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SVPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 30, 2025, September 09, 2025, September 19, 2025, October 31, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of SVPL have been revised on account of delays in debt servicing recognised from publicly available information. i. e. CIBIL check.

About the company

Indore (Madhya Pradesh) based Shivalik Vyapaar Private Limited (SVPL) was incorporated in 2006 by Mr. Rajendra Agrawal along with his family members. SVPL is engaged in the business of manufacturing of batteries and lead. The manufacturing unit of the company is located near Indore with total installed capacity of 45 lakh batteries and 3250 Metric Ton Per Annum (MTPA) of lead as on March 31, 2017.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of SVPL to 'Issuer Not Cooperating' category vide press release dated January 13, 2025 on account of its inability to carry out a review in the absence of the requisite information from the company.
