### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 24, 2024, placed the rating(s) of India Belt Company (IBC) under the 'issuer non-cooperating' category as IBC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. IBC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 09, 2025, September 19, 2025, September 29, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.
