Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 21, 2024, placed the rating(s) of Paresh Rice And Pulse Mill (PRPM) under the 'issuer non-cooperating' category as PRPM had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PRPM continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 06, 2025, September 16, 2025, September 26, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings' has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Khambhat (Gujarat) based Paresh Rice and Pulse Mill (PRPM) was established in 1983 by Mr. Chhotabhai Patel. PRPM is engaged in the milling and processing of non-basmati rice. PRPM is operating from its sole manufacturing plant located in Khambhat (Anand, Gujarat).

Status of non-cooperation with previous CRA: Brickwork has continued the ratings assigned to the bank facilities of PRPM to 'Issuer Not Cooperating' category vide press release dated March 13, 2025 on account of its inability to carry out a review in the absence of the requisite information from the firm.
