### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 23, 2024, placed the rating(s) of UP Alums Private Limited (UAPL) under the 'issuer non-cooperating' category as UAPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. UAPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 08, 2025, September 18, 2025, September 28, 2025 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

UP Alums Private Limited (UAPL), was incorporated in January, 1992, and is currently being managed by Mr. Amish Mehra and Mr. Yogesh Tiwari. UAPL is engaged in manufacturing of chemicals such as Liquid Alumina Sulphate (Ferric and Non- Ferric) used in the paper industry as sizing agents and in water purification/treatment at its two manufacturing facilities located in Uttarakhand. Flourish Paper and Chemicals Limited (FPCL), the group entity of UAPL, was incorporated in June 07, 1995, and is engaged in manufacturing of AKD Emulsion and other allied chemicals used in the paper and textile industry at its manufacturing facility located in Derabassi, Punjab.
