### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated November 15, 2024, placed the rating(s) of M J Home Furnishing (MJHF) under the 'issuer non-cooperating' category as MJHF had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MJHF continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 01, 2025, October 11, 2025, October 21, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Haryana based, M J Home Furnishing was incorporated on March 28, 2015. However, the commercial operations commenced in October, 2018 and are currently being managed by Mr. Hemant Jain, Mr. Shubham Jain and Mrs. Asha Rani Jain as its partners. Prior to June-19, the firm was engaged in trading of thread like polyester yarn. However, the firm has setup the manufacturing unit for manufacturing of grey fabric which finds its end use in wide width bed sheets.
