### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 18, 2024, placed the rating(s) of Meghaaarika Impex Private Limited (MIPL) under the 'issuer non-cooperating' category as MIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 03, 2025, September 13, 2025 and September 23, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

MIPL is closely-held company incorporated in April 2011 by Sethi family. The company started its operations in January 2014 and is engaged in trading of industrial chemicals/plasticizers like polyvinyl chloride (PVC) resin, phthalic anhydride, 2-ethyl hexanol (2EH), Iso-Butyl Alcohol (IBA), melamine, acetone, chlorinated paraffin wax etc. These chemicals are crude oil derivatives and find application in wood polish, printing ink, paints, washing PVC medical and surgical products, wires & cables, non-toxic food containers, erasers, leather cloth, perfumes, vinyl flooring, footwear and PVC shower curtain etc
