### Rationale & Key Rating Drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 16, 2024, placed the rating(s) of Jadeja Industries Private Limited (JIPL) under the 'issuer non-cooperating' category as JIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 01, 2025, September 11, 2025, September 21, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Morbi (Gujarat) based JIPL was incorporated as a private limited company during September, 2004 as Jadeja Refractories Private Limited (JRPL). Subsequently, JRPL was converted into JIPL during December 2013. JIPL is managed by three promoters namely Mr. Keshrisinh Jadeja, Mr. Hitendrasinh Jadeja and Mr. Devendrasinh Rana. JIPL is engaged in to manufacturing of refractory bricks which is used in lining furnaces, kilns, fireboxes, and fireplaces. JIPL operates from its sole manufacturing facility located in Morbi (Gujarat).
