### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated November 26, 2024, placed the rating(s) of Saggi Electric Company (SEC) under the 'issuer non-cooperating' category as SEC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SEC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 12, 2025, October 22, 2025, November 01, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Saggi Electric Company (SEC) was established in 1980 as a partnership firm and is currently being managed by Mr. Yashpal Saggi, Mr. Sabodh Saggi and Asha Saggi. The firm is engaged in providing services in the electrical sector such as engineering, procurement and construction of electrical substation, transmission and distribution transformers etc.

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of SEC into Issuer Not Cooperating category vide press release dated June 13, 2025 on account of its inability to carry out a review in the absence of requisite information.
