Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated November 19, 2024, placed the rating(s) of Arihant Dream Infra Projects Limited (ADIPL) under the 'issuer non-cooperating' category as ADIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ADIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 05, 2025, October 15, 2025, October 25, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Jaipur-based (Rajasthan) ADIPL was originally incorporated in 2011 as Arihant Shivank Infrastructure Private Limited and subsequently, changed its name to ADIPL in August, 2013. ADIPL mainly executes residential and commercial projects in Jaipur and nearby areas. The promoters of the company have significant experience of the executing residential and commercial real estate projects. The company is currently executing five projects and all are in Jaipur namely Arihant Dynasty, Arihant Legacy, Arihant Shree Krishnam Heights, Arihant Sai Residency, Arihant Awana.

Status of non-cooperation with previous CRA: ICRA has continued the rating assigned to the bank facilities of ADIPL into Issuer Not Cooperating category vide press release dated March 21, 2025 on account of its inability to carry out a review in the absence of requisite information.
