### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated November 12, 2024, placed the rating(s) of Chaitanya International Minerals LLP (CIML) under the 'issuer non-cooperating' category as CIML had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. CIML continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 28, 2025, October 08, 2025, October 18, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

### About the company

Udaipur-based (Rajasthan) Chaitanya International Minerals LLP (CIML) was formed as a limited liability partnership concern in September, 2016 by Mr Kapil Agarwal, Mr Ankit Agarwal along with other partners with an objective to set up greenfield project for mineral processing of feldspar quartz and silicon sand. The firm was expected to commence its operations from July, 2017.

**Status of non-cooperation with previous CRA:** Brickwork has continued the rating assigned to the bank facilities of CIML into Issuer Not Cooperating category vide press release dated June 26, 2025 on account of its inability to carry out a review in the absence of requisite information.
