Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 15, 2024, placed the rating(s) of Sonamoti Agrotech Private Limited (SAPL) under the 'issuer non-cooperating' category as SAPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SAPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 31, 2025, September 10, 2025, September 20, 2025 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the company

Incorporated in April 2010, Sonamoti Agrotech Private Limited (SAPL) was promoted by the Kasera family of Patna, Bihar for setting up a paddy milling and processing unit at Karmali Chak, Patna, Bihar. The company commenced commercial production from November, 2013 with rice processing capacity of 58,400 metric ton per annum (MTPA).

Status of non-cooperation with previous CRA: India Ratings has continued the rating assigned to the bank facilities of SAPL into Issuer Not Cooperating category vide press release dated August 21, 2025 on account of its inability to carry out a review in the absence of the requisite information from the company.
