Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 23, 2024, placed the rating(s) of Sree Sree Rakhahari Cold Storage Private Limited (SSRCSPL) under the 'issuer non-cooperating' category as SSRCSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SSRCSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 08, 2025, September 18, 2025, September 28, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Sree Sree Rakhahari Cold Storage Private Limited (SSRCSPL), incorporated in March 27, 2007, was promoted by two brothers Mr Swarup Pratihar and Mr Anup Kumar Pratihar of Paschim Midnapur, West Bengal. Since inception, SSRCS is engaged in the business of providing cold storage facility primarily for potatoes to local farmers and traders on rental basis. The facility, is located at Paschim Midnapur district of West Bengal. Besides providing cold storage facility, the company also provides interest bearing advances to farmers for potato farming purposes against potato stored. This apart it also provides additional services to farmers such as insurance of potatoes stored & drying of potatoes.
