Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated November 25, 2024, placed the rating(s) of Vikas Cotton Industries Private Limited (VCIPL) under the 'issuer non-cooperating' category as VCIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. VCIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 11, 2025, October 21, 2025, October 31, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the Company

Incorporated in the year 2005, VCIPL is promoted by two promoters Mr Bhavinkumar Patel and Ms Palakben Patel. VCIPL is engaged into the business of cotton ginning, pressing, seed crushing with an installed capacity of 350 cotton bales per day as on March 31, 2017 at its facilities located at Mehsana-Gujarat.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of VCIPL into Issuer Not Cooperating category vide press release dated October 24, 2025 on account of its inability to carry out a review in the absence of the requisite information from the company.

CRISIL has continued the rating assigned to the bank facilities of VCIPL into Issuer Not Cooperating category vide press release dated October 30, 2025 on account of its inability to carry out a review in the absence of the requisite information from the company.
