### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated November 28, 2024, placed the rating(s) of King Refineries Private Limited (KRPL) under the 'issuer non-cooperating' category as KRPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KRPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 14, 2025, October 24, 2025, November 03, 2025 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

King Refineries Private Limited (KRPL) was incorporated in July 1994 by Mr. S.A. Arumugam, Managing Director; who has got more than five decades of experience in edible oil refining industry. KRPL is engaged in the business of edible oil refining. The day-to-day operations are managed by the directors, Mr. Venkatachalam and Mr. M. Abinand. KRPL procures crude oil (sunflower oil, ground nut oil and cotton seed oil) from local traders in Tamil Nadu. Apart from the same, KRPL also started importing oil (crude sunflower oil) from Ukraine since October 2015.
