### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 11, 2024, placed the rating(s) of Taneja Overseas (TO) under the 'issuer non-cooperating' category as TO had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. TO continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 27, 2025, November 06, 2025 and November 16, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Taneja Overseas (TO) is a Punjab based, partnership firm established in 2007 by Mr. Avtar Singh Taneja, Mr. Jaideep Singh and Mrs. Satinder Kaur. The firm is engaged in processing of paddy at its manufacturing facility located in Tarn Taran, Punjab.

**Status of non-cooperation with previous CRA:** Brickwork has continued the rating assigned to the bank facilities of TO into Issuer Not Cooperating category vide press release dated March 25, 2025 on account of its inability to carry out a review in the absence of requisite information.
