Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated December 06, 2024, placed the rating(s) of Shree Balaji Woollen Mills (SBWM) under the 'issuer non-cooperating' category as SBWM had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SBWM continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 22, 2025, November 01, 2025 and November 11, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
