Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 15, 2024, placed the rating(s) of Godavari Plasto Containers Private Limited (GPCPL) under the 'issuer non-cooperating' category as GPCPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GPCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 31, 2025, September 10, 2025, September 20, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the company

Godavari Plasto Containers Private Limited (GPCPL) was incorporated in 1997 and promoted by Mr. C. Chandra Prakash, Mr. M. Ramesh and Mr. C. Janardhan Rao. The company is engaged in manufacturing of High Density Polyethylene (HDPE) drums and containers ranging from 20 litres to 270 litres. GPCPL operates from two manufacturing units; one located at Hyderabad with a total capacity of around 4400 MTPA and the second unit being located at Vishakhapatnam with a total capacity of around 3100 MTPA.
